The President introduced Charles F. Wood, a Past President of the Institute of Actuaries. Mr. Wood responded, conveying to the Society the good wishes of the President and Council of the Institute.

The President advised that advice had been received of the deaths of the following since the first pair of spring meetings: Richard Fondiller, Gardner F. Knight, John W. Ritchie, Mervyn Davis, and James Dalrymple, Fellows, and Thomas M. Mott, Associate. The members stood for a minute in silent respect for the memory of these men. Obituaries of these members are printed elsewhere in this number of the *Transactions*.

The President advised that the minutes of the annual meeting held November 13, 14, and 15, 1961, as printed in the *Transactions*, Volume XIII, pages 674 to 684, inclusive, were approved at the regional meeting held May 24 and 25, 1962.

The Secretary presented a summary of the business transacted by the Board of Governors since the Annual Meeting of the Society. The summary included the items previously presented at the regional meeting held March 21 and 22, 1962, and printed in the report of that meeting on page 204 of this volume of the *Transactions* as well as the following additional items of business:

- (1) The Board of Governors approved the application of Frederick W. Stephens, Fellow of the Institute of Actuaries, for admission as an Associate of the Society with waiver of examinations.
- (2) The Board of Governors approved a change in the procedure to be followed in the presentation of formal papers at the meetings of the Society. Upon acceptance, the Secretary is to request the author to submit a written presentation of the paper to be not more than one page in length. The author's oral presentation at the meeting is then to be limited to the written submission.
- (3) The Board of Governors approved a plan under which Part 4A of the examinations of the Society is to be given in both the spring and fall of 1963 on an experimental basis to determine whether this examination should be given twice each year thereafter.
- (4) The Board of Governors authorized the further expenditure of \$2,000 for the development of an actuarial aptitude test. This amount was in addition to the \$4,000 already authorized and is only to be made with the approval of the Committee on Public Relations.
- (5) The Board of Governors noted in its minutes the death of Sir William Elderton, a former President of the Institute of Actuaries.
- (6) The Board of Governors received a report of the Committee on Frequency and Type of Meetings and voted to hold three spring meetings with identical programs for each except for minor variations. The new schedule of spring meetings is to commence in 1964, if possible, and is to

continue in 1965 and 1966. The geographical distribution of the meetings will be as follows: one on the Northeastern Seaboard, one in the Midwest (including Toronto) and one alternating between the Far West, Canada and the South, but not necessarily in the order in which the regions are named.

(7) The Board also approved a recommendation of the Committee that members of the Casualty Actuarial Society be invited to attend the last day of our 1963 Fall Meeting if the Casualty Actuarial Society schedules its meeting immediately following ours and in that event the last day's program will cover topics of mutual interest to both bodies.

The General Chairman of the Education and Examination Committee, Edwin Lancaster, gave a report on the progress of work of his committee in the development of the new syllabus. He advised that it was expected that the first examination under the new syllabus will be held in the fall of 1963.

It was announced that an informal meeting would be held later in the afternoon for members of the Society interested in the field of collective risk theory to appraise the extent of interest in the subject.

The meeting then proceeded to the presentation and discussion of formal papers as printed in this number of the *Transactions*.

A welcome was extended to the new Fellows and Associates who were attending their first meeting after attaining their present rank.

The meeting took up the informal discussion of Topic I of the subjects of general interest with Vice-President Harold R. Lawson presiding.

The meeting adjourned for lunch at 12:15 P.M.

The members reassembled at 2:00 P.M. in two simultaneous sessions for the informal discussion of topics of special interest with Mr. Samuel P. Adams presiding over the session on Individual Life Insurance and Mr. William V. Hauke presiding over the session on Employee Benefit Plans. These meetings adjourned at approximately 4:30 P.M.

On Friday, June 8, the meeting was called to order by President Jenkins at 9:30 A.M. and continued the discussion of the topics of general interest with Vice-President Henningsen presiding over the discussion of Topics II, IV, and V while Vice-President Lawson presided over the discussion of Topic III.

President Jenkins closed the meeting after thanking all those who had assisted in the preparation of the program or who had participated in the discussion.

The meeting adjourned at 12:15 P.M.

Mr. Paul E. Martin called a Smaller Company Forum to order at 2:00 p.m. on Friday. He then presided over the discussion of the topics set forth in the program. This session adjourned at approximately 4:30 p.m.
